## Announcement Concerning Revisions to Projections for Consolidated Financial Results for the Full FY2018

NOK Corporation hereby announces that, in light of its recent operating performance, it has revised its financial projections announced on November 9, 2018 as below.

#### Reasons for the revision

Net sales are projected to decrease due mainly to a decline in sales of products to high performance smartphone manufactures in the electronic product business. In line with the reduced net sales, operating income, ordinary income and profit attributable to owners of parent are also expected to decrease respectively. The consolidated financial projections for the full fiscal year ending March 31, 2019 were therefore revised downward.

Operating results by segment is currently under examination and will be released in the third quarter results announcement scheduled on February 1, 2019.

Based on the above background, the possibility of future recovery of fixed assets owned by the electronic product business is under study pursuant to the Accounting Standard for Impairment of Fixed Assets. The financial impact will promptly be announced as soon as it becomes available.
