

NOK Earns Dual Honors in S&P Global's The Sustainability Yearbook 2025

NOK Corporation (Headquarters: Shibadaimon, Minato-ku, Tokyo; Representative Director, Group Chief Executive Officer: Masao Tsuru; hereinafter referred to as "NOK") has been recognized in The Sustainability Yearbook 2025, published by global research and evaluation firm S&P Global. NOK ranked among the top 15% of companies in its industry based on evaluation scores, earning its place as a Sustainability Yearbook Member. The company was also named an Industry Mover, a distinction awarded to the automotive parts company that demonstrated the most significant year-over-year improvement. This marks the first time NOK has received both honors.



S&P Global evaluates companies worldwide on their sustainability efforts across financial, environmental, social, and governance (ESG) criteria, using its proprietary S&P Global CSA Score. This year, out of more than 7,690 companies assessed, 780 were selected for the 2025 Yearbook.

NOK maintained strong ratings in environmental criteria, particularly in climate change initiatives. In the social category, its evaluation for human rights improved due to the

implementation of human rights due diligence across all subsidiaries. In governance, NOK received high marks for tax strategy, following the establishment of a comprehensive tax policy.
